## Loan shark is jailed and banned from driving

A loan shark who ran a 'payday loan scheme' targeting vulnerable people as he bought and sold games consoles online has been jailed for four years.

Alan Fawcett ran his illegal money lending operation in the Greater Manchester area, giving out around £100,000 in loans and receiving around £130,000 back in repayments over a two-year period, Bolton Crown Court heard. The court was told that when borrowers struggled to repay what they had borrowed, he threatened them, leaving some 'living in fear' for themselves and their families. One of the borrowers said after the hearing: "Alan made me isolate myself and I've not been able to get straight since."

"I still close my blinds, and I don't leave the house. Now hopefully this is finally over I can move on." Fawcett, 54, of Wigan, admitted illegal money lending and money laundering between 2021 and 2023 but disputed the amounts involved and that any threats were involved. After a trial of issue, Mr Recorder Nicholas Flanagan found against Fawcett. He sentenced him to four years in jail for money laundering and 18 months for illegal money lending, to run concurrently. He was also disqualified from driving for four years as driving was an integral part of the offending.

## Pair targeted vulnerable Thai nationals

A couple who acted as loan sharks, targeting vulnerable members of the Thai community, have been handed suspended jail terms.

Christopher Bates, aged 63, and Salujkit Rudchat, 46, appeared at Basildon Crown Court after admitting illegal money lending and money laundering.

His Honour Judge Shane Collery KC told them they acted deliberately, and added pressure and intimidation that affected borrowers' wellbeing and relationships. He sentenced Bates to a total of 19 months in prison suspended for two years while Rudchat was sentenced to 16 months, also suspended for two years.

## 'Ruthless' loan shark locked up

A Wirral woman who acted as a loan shark while she helped her son to supply drugs has been sentenced to 39 months in jail.

Carole Low, aged 65, pleaded guilty to illegally lending money between 2018 and 2025 as well as two counts of conspiracy to supply controlled drugs.

Her son Seng Low, 43, admitted two charges of conspiracy to supply controlled drugs.

They both appeared before Liverpool Crown Court to be sentenced. The judge said Carole Low was involved in "ruthless exploitation" and that her "money lending was to people who were weak, vulnerable and unable to access money".

## Borrower driven to brink of suicide

A man who was driven to the brink of suicide by a loan shark who threatened to set him on fire has bravely shared his story, telling how he escaped the clutches of the ruthless lender with the help of the England Illegal Money Lending Team. Simon, not his real name, spoke out as he wanted to help raise awareness about how loan sharks operate and to stop other people being targeted.

The 46-year-old, from the north-east of England, said he considered his lender a friend who helped out when times got tough. But he ended up afraid to leave the house. **Watch Simon tell the story himself [here](#).**

## 'Financial crime expert' told to pay £170k

A West London man who worked as a qualified anti-money laundering specialist but ran a loan shark operation on the side has had almost £170,000 of his ill-gotten gains confiscated by a court.

Dharmendra Devji Solanki, aged 59, admitted charges of illegal lending and money laundering and was handed a two-year prison sentence, suspended for two years, by a judge at Inner London Crown Court in June last year. He was back before the court on March 11 this year, where he was ordered to pay £169,941.89 after a Proceeds of Crime Act hearing.

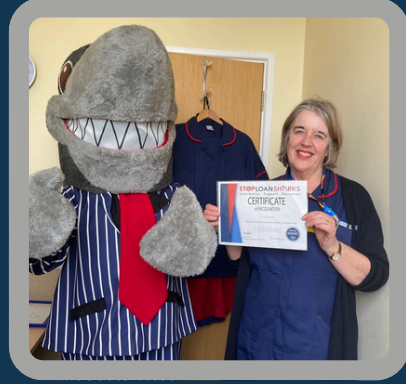

We are supporting West Midlands Police's Operation Fearless, a crackdown targeting the Soho Road and Handsworth Triangle in Birmingham. The operation focuses on tackling the crimes that matter most to local residents and improving safety in the area. As part of a multi-agency approach, we are working alongside police and partners to help keep people living and working in the area safe. If you are nearby, you may spot our campaign messages on local billboards.



In Sunderland, dozens of representatives from organisations across the area recently attended a Stop Loan Sharks charter signing event at Sunderland City Hall. Attendees pledged their commitment to supporting the work of Stop Loan Sharks and tackling illegal lending in their communities.

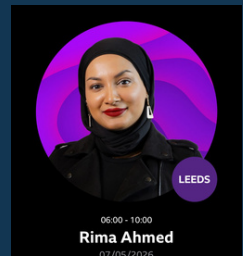

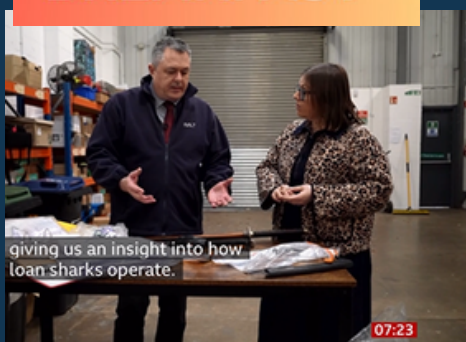

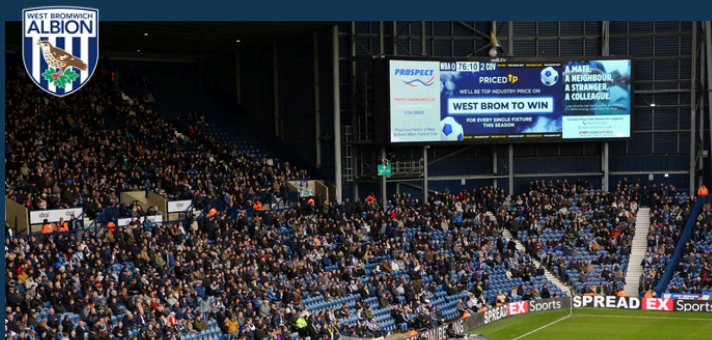

## On the ball and on the buses with Stop Loan Sharks



This season, we've explored new ways to reach more people through our awareness-raising campaigns, including connecting with thousands of football fans. In December, we joined Reading FC at their match against Luton Town to highlight the risks of illegal lending at Christmas, with players wearing Stop Loan Sharks T-shirts ahead of kick-off. In March, we were pitchside at Stockport County FC vs Northampton Town with Glenda the Lender and Sid the Shark, talking to supporters. ## News from Scotland and Wales

### Midlothian loan shark exploited colleagues

Neil Stewart Forrester (59), from Gorebridge, was sentenced at Edinburgh Sheriff Court to 117 hours of unpaid work following a guilty plea to charges of illegal money lending and threatening and abusive behaviour.

The investigation, led by the Scottish Illegal Money Lending Unit (SIMLU), revealed that Forrester, formerly employed as a refuse collector and GMB Union Representative at Midlothian Council's Stobhill Depot, abused his position of trust to exploit vulnerable colleagues. Between January 2018 and August 2022, he issued unauthorised loans ranging from £20 to £500 to at least 14 individuals, enforcing repayments through intimidation and threats. Evidence showed that more than £100,000 was repaid, far exceeding the original loan amounts.

### Three arrests in Fife

On 23rd April 2026, officers from the Scottish Illegal Money Lending Unit (SIMLU), with the assistance of partner agencies, searched 2 premises of suspected loan sharks in Methil, Fife. A 63-year-old female, a 60-year-old male and a 34-year-old male have been arrested on suspicion of illegal money lending.

### Report reveals hidden crisis of coerced debt

A groundbreaking new research report, "[It's always there, like a shadow behind you](#)": Women's Experiences of Coerced Debt and Recovery in Scotland, has uncovered the devastating impact of coerced debt as a form of economic abuse in Scotland and provides recommendations for cross-sector reform.

The report, developed by Scottish Women's Aid and commissioned by the Scottish Illegal Money Lending Unit and Trading Standards Scotland, is the first dedicated qualitative study examining coerced debt as a form of domestic abuse in Scotland.

### Two suspects arrested in Wales

Stop Loan Sharks Wales executed a warrant at a property in the Newport area in March with one person arrested.

The investigation is ongoing, and the suspect is believed to have been active in and around Newport.

And back in December, 2025, the Wales team arrested a 70-year-old man in eastern Cardiff on suspicion of illegal money lending and money laundering. Officers seized cash, mobile phones, electronic devices, and documents. Both investigations are ongoing.

### Former Swansea postmaster admits illegal lending

A 69-year-old man has pleaded guilty at Cardiff Crown Court for running an illegal money lending operation and laundering proceeds of crime.

Jonathan Mark Barry, a former postmaster in Killay, Swansea, pleaded guilty to the offences of illegal money lending and money laundering following a detailed investigation by Stop Loan Sharks Wales.

The investigation into Barry began after Stop Loan Sharks Wales received intelligence indicating that Jonathan Mark Barry was illegally lending money, commonly referred to as loan sharking. In July 2024, officers executed search warrants at his home and at the Killay News and Post Office. During the searches, they discovered £37,000 in cash, along with high-value luxury items including a gold watch, a diamond bracelet and several gold bars. Through his financial records, it was uncovered that Barry was a prolific loan shark and had been operating over a long period of time. Investigators were able to identify approximately 120 victims that had been exploited by Barry across a fourteen-year period. Bank records revealed that he had issued approximately £130,000 in unlawful loans and had received more than £344,000 in repayments and unexplained cash deposits. He charged interest rates ranging from 20% to an astonishing 1,303%, leaving many victims with little or no money to live on after making their repayments to Barry.

He will be sentenced later.

We are grateful to all of our partner organisations across England who do so much to help us find and deal with illegal lending. So how can you help?

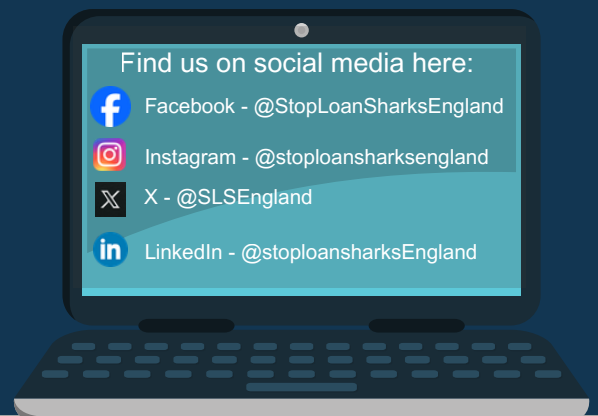
